The Chairman of the "Sector Coordination Council of Employment and Vocational Education and Training" (hereinafter referred as the Coordinating Council) – Mrs. Ketevan Natriashvili welcomed the audience and introduced the issues of the Agenda.

- Report regarding the implementation of the program "Employment and Vocational Education and Training" – Tamar Kitiashvili - Head of the Vocational Education Development Department
- Report regarding the implementation of the program "Employment and Vocational Education and Training" – Davit Lomidze - Deputy Minister of the Labor, Health and Social Affairs of Georgia; Co-Chairman of the "Sector Coordination Council of the Employment and Vocational Education and Training".

Mrs. Ketevan Natriashvili asked the speakers to report regarding the implementation of the activities considered by second tranche of the matrix of "Employment and Vocational Education and Training" policy.

The head of the Vocational Education Development Department of Ministry of Education and Science of Georgia - Mrs. Tamar Kitiashvili and the Deputy Minister of the Labor, Health and Social Affairs of Georgia – Davit Lominadze provided the detailed information regarding all the activities that were implemented within the framework of financial agreement.

As Mrs. Tamar Kitiashvili explained, because the meeting coincided with the end of the year, it will be focused to summarize activities that were implemented by Ministry and its subordinated agencies. She added that all the paragraphs that are included by matrix were successfully implemented and respective evidences will be submitted to the Monitoring Group of European Union. The speaker provided audience with the information regarding the implementation of each paragraph included in the matrix and regarding implemented activities.





The attendants did not have any questions towards Ministry of Education and Science of Georgia so, Mrs. Ketevan Natriashvili finished her speech and asked Mr. Davit Lomidze to continue the report. He introduced all the activities that were implemented in the current year by Ministry of Labor, Health and Social Affairs of Georgia. Regarding all this activities information will be submitted to the Monitoring Group.

Mrs. Nino Kochiashvili said that beneficial Ministries must have developed costed action plan. Representative of Ministries replied that they have already developed such action plans, which were submitted to experts of European Union with other documents.

Mr. Gocha Alexandria expressed his willingness to further involve International Organization of Labor in the process of the development of the documents, because this organization is most competent in labor related issues.

Mrs. Nino Kochiashvili asked the representatives of the Ministry of Education and Science of Georgia and Ministry of Labor, Health and Social Affairs of Georgia regarding the date of experts arrival in Georgia. These experts will provide recommendations regarding the amount of second tranche on the basis of meetings with interested parties, provided reports and documents.

As she said, experts are expected to arrive on 26 January, 2015, but if necessary, date can be delayed. Parties agreed on 15 February to be the date of experts' arrival in Georgia. Beneficial ministries of the program can submit report together or individually. Representatives of the ministries will agree on this issue.
